# President's Corner

## **Moving into the 21<sup>st</sup> Century**

By now, most of us are quite accustomed to going online to shop, track our financial portfolios, check movie schedules or a number of other activities. The GKCPTP board is also making strides to move our chapter further into the 21<sup>st</sup> century.

At the last board retreat in May 2006, we identified several initiatives for the year. We formed small groups to divide and conquer; and we saw the need to help maintain momentum during the transition to a new board and to help ensure organizational continuity (through cross-training or backups). Several areas were taken under consideration. Below is a summary of a few key initiatives the board has acted on:

### **Accounting**

The treasurer's job is currently handled using a combination of manual processes and spreadsheets. **Larry Dolci** diligently researched options and presented a recommendation to the board. The board agreed to move forward with the purchase of a basic laptop and software to automate bookkeeping.

### **International Military Sponsorship**

A committee focusing on international military sponsorship met over the last several months to understand and document the sponsorship processes. Committee members **John Cessna**, **Barbara Dolci**, **Carol Douglass**, **Sonia Eichenwald**, **Gwenn Puetz** and **Sharon Valasek** also looked for ways to reduce the time and labor involved. **John Cessna** (along with neighbor Earl) recommended implementation of a Microsoft Access program to automate many steps in the process. Additional benefits include database tracking and reporting.

### **Chapter Manual**

Committee members **Dyrk Dugan**, **Gene Jacobs**, **Sharon Valasek** and **Gail Ward** are working on this initiative. **Gene** is writing a draft version of the manual. Board members are providing details about their respective roles and responsibilities. The manual will be used as a "day-to-day" operating guide for the board. Benefits include better transition from outgoing to incoming boards and better preparedness for continuity of operations.

### **Membership Directory**

### **Treasurer's report**

### **Student Loan and Scholarship Program**

President **Sharon Valasek** proposed that **Jerry Ward** meet with PTPI to explore that option and report back to the board. GKCTP would continue to select candidates for loans and scholarships.

### **Military programs**

**John Cessna** presented information on a computer program that would increase efficiency in the documentation/sorting process of sponsor-officer matching. This program uses Microsoft Access functionality. There would be an expense to setting up this system by a programmer. It was recommended that the board learn more about this potential time saving program. The military programs/initiatives committee has documented the sponsor-officer matching process and is in the process of creating a flow chart for the chapter manual.

# Jake and Linda's Belize Adventure

As part of our activities in People to People International, **Linda** and I have been sponsoring military officers from a variety of nations around the world for 21 years. Occasionally, we have the opportunity to visit one of our former officers and his friends and family in his country of origin. January 2007 presented one of those opportunities when we traveled to Belize to spend a long weekend with Brigadier General **Lloyd Gillett** who now is the commandant of the Belize Defense Force (BDF).

We arrived in Belize City at 3:15 p.m. Thursday, January 18. Lloyd met us at the airport, and Willoughby, his driver, took the three of us to our hotel. Since Belize is in the same time zone as Kansas City and the flight from Dallas is about three hours, there was no need to adjust to anything resembling jet lag. We dropped our luggage in our room and adjourned to poolside for a cool drink and an opportunity to catch up on each others lives in the years since our last time together. Having left sub-freezing temperatures in Kansas City that morning, enjoying a cool beverage at poolside was a real treat.

After an hour or so, Lloyd left us to freshen up for dinner. We were to join a visiting U.S. military delegation from San Antonio headed by BG **Ken Keen** and would have the opportunity to meet **Maria**, Lloyd's "best friend," at a museum/restaurant called Old Belize. Upon arrival, we met BG Keen, his party and the beautiful and charming Maria, whose grace and hospitality added greatly to our enjoyment of our visit. We enjoyed a guided tour of the museum which quickly brought informed us a great deal about the history of the country, formerly British Honduras.

At dinner, we were introduced to Marie Sharp's habañero pepper sauce, a staple on tables at nearly every restaurant we were to visit. I brought several bottles home.

Friday morning, we were collected at the hotel by Willoughby and Lt. Neal, a BDF public relations officer. They escorted us to another museum and a driving tour of Belize City. We were to meet Lloyd at the BDF airfield at 1 p.m., but unusually heavy recent rains had wiped out part of the highway to Ladyville, the town in which the airport and the BDF barracks are located. After a delay, we were able to get around the construction crew which consisted of several men leaning on shovels. Lloyd referred to the signage as "Slow Men Working" emphasizing the lack of a comma.

When we arrived at the airfield, we discovered that we were going to fly to San Pedro on a BDF plane. San Pedro is a village on the core of Ambergris Caye, the larger and more populated of the Cayes in Belize. It is also the city with more tourist attractions, making it an important catalyst for all the water-based activities in Belize. Lloyd, who has been in the aviation branch of the BDF most of his career, would fly the plane with another Lt. Neal as copilot. When he as a captain, Lloyd was **Queen Elizabeth's** personal pilot during her visit to Belize. He was told that she would present him with a gift at the conclusion of her trip, and he asked his copilot to find out what it would be. He learned that she planned to give him an autographed picture. When she did so, he smiled and told her that it was the custom in Belize to reciprocate in like fashion when given a gift and presented her with an autographed picture of him. Is the story apocryphal? Perhaps, but Lloyd loves to tell it and we always enjoy hearing it.

We were delighted to find that the five inches of snow that had fallen on Parkville during our stay in sunny Belize had not buried our car in the KC I parking lot. The neighbors had cleared most of our driveway and brought our mail into the house where is awaited us. Arriving at nearly midnight, we slept very well our first night home and awoke Wednesday morning already thinking of when we might be able to return to this lovely country in which we had met so many wonderfully remarkable people.
